Dear Secretary Buttigieg:

The Heartland Civic Collaborative (HCC) is fully supportive of the joint Kansas and Oklahoma application for funding a Service Development Plan (SDP) for the Heartland Flyer, which will reflect regional and FRA interest in advancing the corridor to implementation and operation.

The Kansas Department of Transportation and Oklahoma Department of Transportation intend to jointly apply for the Heartland Flyer Extension from Oklahoma City, OK to Newton, KS to be selected for the Corridor ID program, reconnecting numerous Oklahoma and Kansas communities north to the national Amtrak network via the Southwest Chief. The HCC agrees with both KDOT and ODOT in believing the Heartland Flyer Extension has a compelling case for being included in the program.

The Heartland Civic Collaborative serves as the collective business voice of the four participating metros and identifies mutually beneficial opportunities in the areas of transportation, entrepreneurship, life sciences and federal advocacy.
